ORDER

On approval of the List of institutions
Health care, chairmen of commissions and
deputy chairmen of commissions, entitled to
right to conduct medical examinations of seamen

In pursuance of Clause 3 of the Order of the Ministry of Health of Ukraine № 347 dated 19 November 1996 "On approval of Rules for determining fitness for work on ships", registered at the Ministry of Justice of Ukraine on April 3, 1997 № 108/1912, in order to improve organization of medical examinations of seamen and determining fitness for work on ships

DECISION:

1. Approve List of health care institutions, chairmen of commissions and of health care institutions, chairmen of commissions and vice-chairmen of commissions, having the right to carry out medical examinations of seafarers of seafarers, which is attached.
2. To declare null and void the Order of the Ministry of Health of Ukraine from April 05, 2018 No 627 "On approval of the List Health institutions, chairmen of commissions and deputy chairmen of commissions have the right to conduct medical examinations of seafarers".
